## <u>CITY ADMINISTRATIVE REPORTS</u>

INTERIM CITY ADMINISTRATOR WILLIAM HALL: MONTHLY FINANCIAL REPORT – FISCAL YR 2021 PERIOD ENDING APRIL 30, 2021. The following is a summary of the City's financial results for the major operating funds as of April 30, 2021. Fiscal year activity has been included as of May 7, 2021.

#### **GENERAL FUND:**

REVENUE - Budgeted: \$6,728,750; YTD Actual Collected = \$5,250,637 representing 78% of the current budget compared to the prior year actual collected = \$5,234,851. The Use of Fund Balance = \$470,741.

EXPENSES – Budgeted: \$7,199,491; YTD Actual Collected = \$6,144,523 representing 85% of the budget compared to the prior year actual = \$5,182,416.

REVENUE OVER (UNDER) EXPENDITURES: YTD = (\$893,886); PRIOR YR ACTUAL = \$52,435

#### WATER FUND:

REVENUE – Budgeted: \$1,549,573; YTD Actual Collected: \$1,243,354 representing 80% of the budget compared to the prior year actual: \$1,309,171.

EXPENSES – Budgeted: \$1,549,573; YTD Actual Collected: \$1,069,941 representing 69% of the budget compared to the prior year actual: \$1,041,362.

REVENUE OVER (UNDER) EXPENDITURES: YTD = (\$173,413); PRIOR YR ACTUAL = \$267,809.

#### **SEWER FUND:**

REVENUE – Budgeted: \$2,758,350; YTD Actual Collected: \$2,484,715 representing 90% of the budget compared to the prior year = \$2,374,430.

EXPENSES – Budgeted: \$2,758,350; YTD Actual Collected: \$2,179,137 compared to the prior year actual = \$1,893,096 representing 79%.

REVENUE OVER (UNDER) EXPENSES – Budgeted: \$0; YTD Actual Collected: \$305,578 compared to the prior year actual = \$481,334.

**APPROVAL OF BILLS FOR THE MONTH OF MAY 2021** (page 86) – Approved Items 1 - 8 as presented.

A motion to approve the May 2021 Bill List items 1–8: Councilmember Wilhelmena Scott; Seconded: Councilmember Sondra Fleming-Crosby; Discussion: Councilmember Richard Cook inquired about the status of the street closing on Dansing Street? This street has been closed for some time now, and it is his opinion that it needs to be opened back up by now. Interim Administrator William Håll and Public Works Director Ricky Sims provided some insight but stated that they would need to look into this matter and come back at a later date with their findings. Mayor Anderson Jr. added some input by stating this area is the concern of the South Carolina Department of Transportation; they would need to be included in the talks as well; Motion Carried: All Ayes (Councilmember Richard Cook, Councilmember Sondra Fleming-Crosby, Councilmember Wilhelmena Scott, Councilmember Yamekia Robinson, Councilmember William Askins and Mayor Lovith Anderson Jr all voted Aye).

## **PUBLIC SAFETY REPORTS**

Lake City Police Chief Joseph Cooper provided a summary of the responses, incidents, and domestic situations they have responded to for the last three months to Mayor and Council:

- 61 tickets have been issued
- 6 warrants and arrests
- 19 arrests
- 25 assaults

- Arrests have been made pertaining to the Cadillac convertors and they are continuing to seek others who have been named.
- Domestic and sexual assaults: 1 arrest, 8 arrests in the 2<sup>nd</sup> degree
- They are continuing to operate with a limited staff, but the Lake City Police Department has notice more corporation from the community. Chief Cooper still asks for help from the community in solving cases and policing our city.

Lake City Fire Chief Randy Driggers provided a summary of the responses, incidents, and domestic situations they have responded to for the last three months to Mayor and Council:

- Data from Saturday 05/09/2021 COVID-19 Update
- New confirmed cases 192 (new confirmed cases in Florence County 6); total confirmed cases 486,282.
- New confirmed deaths 0; total confirmed deaths 8,448.
- The FDA has issued an emergency use authorization for the use of Pfizer COVID-19 vaccine in children ages 12 and older.
- South Carolina is awaiting the official recommendations from the CDC before notifying our state's providers that they may begin administering the Pfizer vaccine to those 12 and older. Parental consent is required, as a reminder, in the state of South Carolina, those 16 and older do not need parental consent to receive a vaccine from an authorized vaccine provider.

She stated that she was excited to see that one of the showcase items during the upcoming Annual Meeting in July 2021, is the Lake City Continuum. Representatives from our area will be presenting information about the programs and different options that are available at the Continuum. She encouraged everyone to be honored at the things we have accomplished, to keep an open mind especially as it pertains to protecting ourselves during this pandemic and challenged everyone to at least try to experience or explore different things. She thanked all the City of Lake City's staff, and she wished all the mothers a very Happy Mothers' Day.

Councilmember Sondra Fleming-Crosby – she thanked everyone for coming out and she wished all the mothers a very Happy Mother's Day.

Councilmember Yamekia Robinson - she thanked everyone for coming to the meeting, and she wished all the mothers a very Happy Mother's Day. She wished everyone a safe and Happy Memorial Holiday. The District 4 Community Zoom meeting was rescheduled for May 2, 2021. She stated that the attendance numbers were not what she hoped for, but she is going to continue to have these meetings and encouraged the community to utilize this time to bring their concerns and issues to the forefront. She stated that she attended the South Carolina Community Development Association Annual Meeting, and she felt it was a great opportunity to network and learn of new possibilities for projects in our area. In her opinion, ArtFields was successful this year. She encouraged everyone to continue to wear their masks, especially if they have not been vaccinated. COVID-19 is still out here, and everyone is not fully vaccinated. On Saturday, May 15, 2021, Moore Botanical Garden held an event from 8:30 a.m. until 3 p.m., and she encouraged everyone to go. She also stated that she has been in communications with the RaShaud Graham Committee to find out what the plans are for the upcoming June 12, 2021, date. At this time nothing had been decided and she stated that this year they were hoping to something more geared toward the youth in the committee. She would provide updates as she receives them.

Councilmember Richard Cook – he stated that he really enjoyed seeing all the people in town for ArtFields. He stated that hopefully we find more events to keep our downtown full of people; maybe we can sponsor monthly events to bring people back. He thanked everyone for coming out.

MAYOR'S REPORT – he dittoes the sentiments of the Councilmembers pertaining to ArtFields.

• The City of Lake City is sponsoring a Game and Movie Night on June 18, 2021, beginning at 6 p.m. on the Green. More information will be provided closer to the date.

- COVID-19 vaccinations were given at Saint James Church and Mount Claire Baptist Church on Saturday, May 21, 2021. Dr. Brown and his staff was present at these events to administer shots and provide additional information.
- A reminder of the holiday schedule for the trash pickups was made available and was posted on the City's Facebook page and website.
- He recognized the current Councilmembers and stated that in his opinion; there was a good mix and hope that they will work together to move the City forward.
- He thanked the Interim City Administrator/Finance/Human Resources Manager William Hall, and he thanked all of the City's staff for all the hard work that they put into keeping the city functioning.
