# **LAKE CITY BOARDS, COMMISSIONS AND COMMITTEES**

## **AIRPORT COMMISSION**

**Seven Members minimum, three year terms, appointed by Council, vacancy by Council  
Pursuant to the Code of Ordinance, SC  
Section 2-15 Et Seq.**

## **ARCHITECTURAL REVIEW BOARD**

**Five Members serving two year terms, appointment by City Council. Membership should be identified by place numbers 1-5 with terms of office for members in the odd-numbered places shall expire in odd numbered years; terms for even-numbered members shall expire in even-numbered years; if any place on the Board becomes vacant due to resignation, removal, or for any reason, the Mayor shall appoint a replacement within 60 days for the remainder of the unexpired term, subject to confirmation by the City Council.**

## **HOUSING AUTHORITY**

**Five Members of the Housing Authority serving five year terms. These terms are appointed by the Mayor/Councilmembers.**

## **Pee Dee Regional Transportation Authority Board**

**One Member serving three year terms, appointment by City Council. Membership should be identified by place numbers 1-5 with terms of office for members in the odd-numbered places shall expire in odd numbered years; terms for even-numbered members shall expire in even-numbered years; if any place on the Board becomes vacant due to resignation, removal, or for any reason, the Mayor shall appoint a replacement within 60 days for the remainder of the unexpired term, subject to confirmation by the City Council.**

## **LAKE CITY PLANNING COMMISSION**

**Four year terms, seven members appointed by Council, staggered so that one-fourth of the members shall have terms expiring in each year.**

## **BOARD OF ZONING APPEALS**

**Five Members, appointed by City Council for terms of four years, staggered so that one-fourth of the members shall have terms expiring in each year.**
